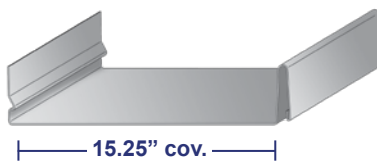

# 40 YEAR LIMITED WARRANTY

Ottawa Valley Metal Inc. (the "Company") warrants that for a period of Forty (40) years following the original date of purchase, provided that all terms and conditions of this warranty are first met, the paint film of the pre-painted Weather XL®, Granite® Deep Mator Perspectra PLUS Series or equivalent Steel Roofing Panels and Siding Panels (collectively the ("Warranted Product") will not crack, blister or peel when used within Canada and the Continental United States of America under normal atmospheric conditions and excluding corrosive or aggressive atmospheres; and for the first Thirty (30) years following the original date of purchase, as determined by ASTM D4214 Method A, the vertical Warranted Product and the non-vertical Warranted Product will not chalk more than eight (8) and six (6) ratings respectively. The Company also warrants that for the first Thirty (30) years following the original date of purchase, the vertical and the non-vertical Weather XL® and Perspectra PLUS Series or equivalent products will not change colour more than five (5) and seven (7) colour units respectively; and the vertical and the non-vertical Granite® Deep Mat product will not change colour more than five (5) and eight (8) colour units respectively. The colour change shall be measured by any accepted colorimeter designed to produce reflectance readings in the Tristimulus Filter System of X, Y and Z based on the CIE values of illuminant C and measured in Hunter L, a and b units determined by ASTM D2244 on clean surfaces only.



## 01. Limitations and Exclusions

The above-mentioned Limited Warranty does not apply to other causes of degradation including:

- a) Failure to store the non-vertical Warranted Product in a way preventing the accumulation of standing water on the coating or in way preventing chemically aggressive environment containing fumes, ash, cement dust, carbon black, salts or other chemicals, whether naturally occurring or caused by man.
- b) Damage to the Warranted Product caused:
  - i. directly or indirectly by contact with fasteners;
  - ii. by non-uniform conditions of exposure or use;
  - iii. by contact with steel shavings or minute particles from sawing sparks;
  - iv. by edge corrosion or substrate corrosion;
  - v. by abnormal atmospheric conditions, such as but not limited to chemical fumes or salt spray, high-pressure water spray, animal waste or airborne contaminants;
  - vi. by moisture entrapment in crates and/or handling, shipping, transit, processing, improper storage or installation;
  - vii. by alteration or modification of the Warranted Product in a manner not originally intended, after delivery by the Company;
  - viii. by unforeseeable causes such as, but not limited to acts of God, falling objects, snow/ice removal, fire, explosion, radiation, vandalism, riots, civil commotion's, acts of war, or other external occurrences beyond the control of the Company;
- c) Minor colour variances between separate orders.

## 02. How to Obtain Services

- a) The customer shall exercise diligence and inspect the Warranted Product prior to installation so as to mitigate expenses involved in refinishing or replacing defective products.
- b) Claims under this Limited Warranty must be submitted in writing and addressed to the Company at its current address within 30 days after the owner becomes or should have been aware of any alleged defect, and must include adequate identification of materials involved in the claim such as, but not limited to representative photos, the date of the installation, the original invoice, the original shipping document or such other sufficient documentation as may be reasonably required by the Company.
- c) Time is of the essence and failure to give notice within the specified time shall discharge the Company from all warranty obligations.
- d) The Company, its agent, employee or representative must be given reasonable opportunity to inspect the Warranted Product that is the subject of a claim.
- e) Any refinishing or replacing not authorized by the Company shall release the Company from all liabilities and obligations with respect to the Warranted Product involved.
- f) If the Company determines that a claim for a defective Warranted Product is valid, the corrective actions to be taken to fulfill the obligations of the Company under this Limited Warranty shall be at the sole discretion of the Company. If the claim is not the responsibility of the Company under this Limited Warranty, the customer shall bear all expenses related to the inspection.

## 03. Exclusion of Warranties and Limitation of Liability

- a) THIS LIMITED WARRANTY CONSTITUTES THE SOLE REMEDY APPLICABLE IN CONNECTION WITH THE WARRANTED PRODUCT. ALL OTHER WARRANTIES, CONDITIONS OR REPRESENTATIONS EITHER EXPRESSED, IMPLIED, STATUTORY OR OTHERWISE, INCLUDING ALL WARRANTY AS TO THE MERCHANTABILITY OR FITNESS OF THE WARRANTED PRODUCT, ALL OF WHICH ARE LIMITED TO THE EXPRESS TERMS AND CONDITIONS HEREOF. NO OTHER WARRANTIES ARE GIVEN BEYOND THOSE SET FORTH HERE IN. ORAL STATEMENTS DO NOT CONSTITUTE WARRANTIES AND ARE NOT PART OF THIS AGREEMENT OR ANY OTHER CONTRACT FOR SALE.
- b) In no event shall the Company be liable for any losses, expenses or damages whether indirect, incidental, or consequential sustained by the customer arising from the use or installation of the defective Warranted Product. The liability of the Company arising from the use or installation of the defective Warranted Product, whether based on warranty, contract, tort or otherwise is expressly limited to the then-current purchase price of the Warranted Product.
- c) This Limited Warranty will not become effective if the invoice/contract for this project is not paid in full to the Company in accordance with the standard terms and conditions set forth in agreement of sale or contract.
- d) The Company reserves the right to discontinue and/or make changes to this Limited Warranty.
- e) This Limited Warranty is extended to the customer alone and shall not be transferable or assignable.
- f) This Limited Warranty shall be governed by the laws of the Province of Ontario and the Laws of Canada applicable therein.
